The trail connects outdoor recreation sites where visitors can view birds and wildlife, as well as experience the local historical, paleontological, and archeological sites. The section of the trail crossing in Bent County is the Plover Trail and not only offers a wide diversity of Plovers, but also of other birds, mammals, wildlife, and reptiles to be observed, photographed, and enjoyed. Bent County has 373 documented species of birds.

#### **WIND POWER PROJECTS**

Wind Power is becoming the fastest growing renewable energy source. In Bent County, we are home to the 75-megawatt capacity Twin Buttes Wind Power Project, built to help meet Colorado's demand for clean, renewable energy. The Twin Buttes project uses 50 plus wind turbines standing 328 feet tall across 9,000 acres of wind swept prairie. Wind energy is plentiful, renewable, and clean. The project generates local income, boosts the local tax base, and attracts tourists.

The Colorado Enterprise Zone (EZ) Program is designed to promote a business-friendly environment in economically distressed areas by offering state income tax credits that incentivize businesses to locate and develop in and non-profit organizations to assist with the needs of these communities. The Enhanced Rural Enterprise Zone (EREZ) program provides greater financial incentives to businesses to promote and encourage new job creation in designated rural Enterprise Zone counties.

In 1870 the county of Bent was formed and named after William Bent, an early trapper, trader, and pioneer. Today the area is rich with recreational activities, historical sites, and western traditions as well as birding trails, excellent schools, and opportunities for business expansion and relocation. Most employment for the citizens is found in the area of agriculture as well as the Bent County Correctional Facility. County and city government, health care, schools, and cottage industries provide the balance of employment. **SUPPORTIVE RESIDENTIAL COMMUNITY** 

The Fort Lyon Supportive Residential Community is located

on the historic Fort Lyon campus seven miles east of Las

Animas. Fort Lyon, originally named Fort Wise, was con-

structed in 1860 as an Army post several miles east of its

current location. In 1861 the name was changed to Fort Lyon

after General Nathaniel Lyon, the first Union general to die in

battle in the Civil War. The Fort was moved to its current

location in 1865. It continued to be used by the Army until the

Department of the Navy assumed ownership in 1906 for use

as a tuberculosis sanatorium. The Navy occupied the site

until 1922 when the Veterans Administration took it over. The

VA originally carried on the work with tuberculosis, but soon

changed its mission to that of a neuro-psych hospital. It con-

tinued that mission until the VA transferred ownership of the

facility to the State of Colorado in 2001. The Colorado De-

partment of Corrections utilized the site as a Correctional

Facility until 2011; and in 2013 the Fort Lyon Supportive Resi-

dential Community was established. The Residential Com-

munity, a program of the Colorado Department of Local Af-

fairs, Division of Housing, provides recovery oriented transi-

tional housing to as many as 250 homeless persons from

FORT LYON NATIONAL CEMETARY

AND KIT CARSON MEMORIAL CHAPEL

Fort Lyon, CO is located on Highway 50, seven miles east of

Las Animas, CO. Located at Fort Lyon, you can visit the Kit

Carson Memorial Chapel, constructed of thick, native stone

with beautiful stained glass windows that depict the heritage

of pioneer life. The chapel is a lasting memorial to Christo-

pher (Kit) Carson and is constructed of material from the ac-

Indian agent, and frontiersman died after a brief illness on

tional Cemetery. Records indicate the first veteran interred at

Pennsylvania who served during the Spanish American War.

The cemetery was transferred to the National Cemetery Sys-

tem in September 1973 and listed on the National Register of

### JOHN W. RAWLINGS HERITAGE CENTER

The John W. Rawlings Heritage Center is located at 560 Bent Avenue in Las Animas. The two story sandstone building was originally the 1898 IOOF Hall which shows the return of the area to prosperity following the depression of the early 1890's. The building presently houses artifacts and information that were affiliated with the Kit Carson Museum. The museum is a place where history and culture come together. The facility serves as the headquarters of the Bent County Historical Society where historical artifacts are displayed, preserved, documented, and interpreted from the days of Kit Carson through the present. #### BOGGSVILLE

Two miles south of Las Animas, on Colorado Highway 101, is located the National Historic Site, Boggsville. Once a major stop on the Santa Fe Trail, this is where, in about 1862, Thomas O. Boggs, along with his wife Rumalda Luna Bent, (stepdaughter to Charles Bent), L. A. Allen, and Charles Ritc founded Boggsville. Boggsville was the first permanent, nonmilitary settlement in Southeast Colorado. This settlement became the center for trade, agriculture, education, and culture as well as the first county seat of Bent County. Although in the height of its existence there were more than twenty structures located at Boggsville, only three have been reconstructed to date complete with period items and furnishings. Visitors to Boggsville will realize the importance of the women and how they brought not only elegance and beauty to the settlement, but it was their claims to the land that made the settlement possible through the Vigil-St Vrain land grant and the Sand Creek claims.

#### **BENT'S NEW FORT**

When Bent's Old Fort was destroyed in 1853, William Bent moved east about 30 miles and built a new trading post on a bluff overlooking the Arkansas River. The stone walls stood 16 feet high and surrounded a large courtyard with many rooms and a 55 foot long warehouse. Unlike Bent's Old Fort, it had no bastions but it did retain the cannons of the earlier fort which were mounted on the corners of the roof. The trading post was not a success but it did play a pivotal role in shaping the American West. The site includes ruins of the foundation, a walking trail, and interpretive exhibits.

#### **SANTA FE TRAIL SCENIC BYWAY**

In 1821, the Santa Fe Trail trade route that connected Franklin, Missouri and Santa Fe, New Mexico was first used by
William Becknell when he organized a trading party and
hauled goods to Santa Fe to trade and sell. Later it was used
as an international commercial highway, a military route, and
finally a route to help open the region to economic development and settlement. Today, the highway route that roughly
follows the Santa Fe Trail's path through Colorado and into
northern New Mexico is called the Santa Fe Trail Scenic Byway, Mountain Branch. The byway, which is 188 miles long,
begins on Highway 50 at the eastern Colorado border and
continues west through Prowers, Bent, and Otero Counties
ending in Santa Fe, New Mexico. As you travel the byway
you can view monuments, actual wagon ruts, rubble of homesteads, and historical sites.

## JOHN MARTIN RESERVOIR RECREATION AREA AND STATE PARK

John Martin Reservoir is located approximately 17 miles east of Las Animas. It is one of the largest reservoirs in the state and is a recreational haven in Southeast Colorado known for its fishing and water sport activities. The park offers full service camping, boating, picnicking, hiking, fishing, wildlife, and bird watching. The park is home to Bald Eagles during the winter months and the sand and gravel shores are among the few remaining nesting areas in the State of Colorado for the threatened Piping Plover and the endangered Interior Least Tern. The visitors center is located at the entrance of the park and offers an interactive dinosaur track display with actual tracks from the track site discovered in 2004. The dam is 2.6 miles in length and 118 feet high. Construction on the concrete and earthen dam was completed in October 1948 at a cost of \$15 million. For the hiking enthusiasts, the Red Shin Hiking Trail begins at the stilling basin below the dam and winds through the park to the Santa Fe Trail marker on the north shore of the reservoir passing historic canals, Native American rock art, and the Prowers-Hudnall Ranch.
